COOKIES POLICY

Like most websites, Bestov.be uses cookies to collect information. Cookies are small data files which are placed on your computer or other devices (such as smart 'phones or 'tablets') as you browse this website. They are used to 'remember' when your computer or device accesses our websites. Cookies are essential for the effective operation of our website.

Some cookies collect information about browsing when you access this website via the same computer or device. This includes information about pages viewed and your journey around a website. We do not use cookies to collect or record information on your name, address or other contact details. Bestov.be can use cookies to monitor it's visitor's general browsing behaviour.

The main purposes for which cookies are used for technical purposes essential to effective operation of our websites, particularly in relation to on-line site navigation.

If you want to disable cookies you need to change your website browser settings.

LINKS TO OTHER WEBSITES

Our web site contains links to information on other web sites. On web sites we do not control, we cannot be responsible for the protection and privacy of any information that you provide while visiting those sites. GOOGLE ANALYTICS

When someone visits www.bestov.be we sometimes use a third party service, Google Analytics, to collect standard internet log information and details of visitor behaviour patterns. We do this to find out things such as the number of visitors to the various parts of the site. This information is only processed in a way which does not identify anyone. We do not make, and would never allow Google to make, any attempt to find out the identities of those visiting our website.

MAILING LIST

As part of the registration process for our e-newsletter, we collect some personal information. If you subscribe through our website, we will only have the emailaddress you have entered and this emailaddress will be collected in our mailinglist "Fans". We use that information to keep you informed on our activities. If you subscribed by sending us a direct email, you might be put in a categorie depending on occupation and region. We use a third-party provider, MailChimp, to deliver our newsletter. We gather statistics around email opening and clicks using industry standard technologies to help us monitor and improve our e-newsletter. For more information, please see MailChimp's privacy notice.
